The freight haul will use the natural terrain of the property. Note: there are sheep and horses on the property. PLEASE KEEP YOUR DISTANCE FROM THE HORSES AND SHEEP AND DO NOT LET YOUR DOGS APPROACH THEM. Porta Potties will be available, but no running water or electricity. This is private property so draft equipment may be left overnight.

# **Driving Directions/Parking:**

\_From the West/South Via the 91 Freeway: Take the 91 Freeway to the 71 (Chino Valley Freeway) North. Take 71 North to the Peyton/Riverside Drive exit. Turn right on Riverside Drive. Travel East ¼ mile to McCroskey Road (on the south/right side) of the street. Turn right on McCroskey Road. Drive to the end/entrance to Diamond Dogs K-9 Events Center. If you pass Reservoir Ave. you have gone too far.

From the West/South/North Via the 5 Freeway: Take the 57 Freeway north for about 18 miles. Keep to the left to take the 60 Freeway East Exit at Reservoir and head South. Turn right onto Riverside Dr. and then a quick left onto McCroskey. Drive to the end/entrance to Diamond Dogs K-9 Events Center.

The Bernese Mountain Dog Club of America Draft Tests are a series of exercises designed to develop and demonstrate the natural abilities of purebred Bernese Mountain Dogs in a working capacity involving hauling. The Bernese Mountain Dog has historically functioned as a draft dog in various capacities, and performance of these exercises is intended to demonstrate skills resulting from both inherent ability and training which are applicable to realistic work situations. Efficiency in accomplishment of tasks is essential. It is also desirable that the dog evidence willingness and enjoyment of his work in a combination of controlled teamwork with his handler and natural independence.

## **Regulations**

**Draft Test Regulations**: Entrants are responsible for obtaining the BMDCA Draft Test Regulations (revised as of Jan 2023) and being familiar with them.

#### Class Entry Details

- •There will be a limit of 26 entries per test.
- Entry fees \$ 40.00 for each single dog team and \$ 50.00 for a brace team
- •A separate entry form must be filled out for each dog of a brace team and then submitted together. Even though two entry forms are required for each brace team, each brace team will be counted as one entry in the Draft Test entry limit.
- •If more than 26 entries are received, they will be prioritized per the following order:
  - 1. Untitled BMD's in the entered class
  - 2. Titled BMD's without Advanced/Master titles in the entered class
  - 3. Titled BMDs with Advanced/Master titles in the entered class
  - 4. Untitled other dogs in the entered class
  - 5. Titled other dogs without Advanced/Master titles in the entered class
  - 6. Titled other dogs with Advanced/Master titles in the entered class
  - Note: For brace teams, the dog with the lowest level title in the entered class determines the team's priority. If a brace has a BMD and a non-BMD, it is considered a "BMD team" for the above.
  - Note that "titled" means titled in the entered class.
- •Running Order: A separate random draw to determine the running order for each class for each test.
- •Entrants must notify the Draft Test Secretary if a dog has earned a title in the entered class, including if the title is earned after the entry has been submitted.

# **Attention Exhibitors**

- •The following classes will be offered: Novice, Brace Novice, Open and Brace Open.
- •Handlers must provide their own rigs, harnesses, and tie downs or other means of securing a load on their particular draft rig.
- •Handlers must bring their own weight. Weight will be verified via scale at the test site.
- •Entered dogs must be 24 months old or older on the day of the Draft Test.
- •Bitches in season are not permitted to compete.
